

## **Early Help Offer**

We will work with children and families and we will:

## Aim to:

- Work to families' strengths, especially those of parents and carers and take time to understand their needs fully.
- Focus on preventing problems before they occur and offer flexible, responsive support when and where it is required.
- Base all we do on evidence, both what is needed and what works. We will be resolute in our commitment to act to ensure the safety and wellbeing of the child.
- Use all resources available to school to support families

Chapel-en-le-Frith High School's early help offer identifies the needs of children and provides support that is more intensive, once other mechanisms in school have failed to address the issues. For this to be effective, we will work together with other agencies to:

- ✓ Identify children and families who would benefit from support
- Undertake an assessment of need
- ✓ Provide intervention and signposting to address those needs


Our Early Help offer is delivered by our Family Outreach Manager Mrs Andrea Parry.

Our Family Outreach Manager will work with families to identify the right level of support, which can be delivered quickly in order to prevent things getting worse. This may require working with other agencies. In these cases, there would be a responsibility to share information in line with our Sharing Information Policy. The Family Outreach Manager will carry out an Early Help Assessment and co-ordinate action plans in the form of a TAF (Team Around the Family) plan.

Early Help is the support that is delivered at Level 1 and Level 2 of Derby and Derbyshire's Safeguarding Children Partnership Thresholds Document. It includes 'Universal' interventions that are offered to all children at Chapel-en-le-Frith High School to prevent problems developing, and 'Emerging Needs,' which is more targeted support to particular children and families who present with additional needs.

The purpose of Early Help is to support the well-being of children and families by tackling emerging needs at the earliest opportunity to support, educate and prevent further escalation. This means working with children and families, engaging them as equal partners and to helping them engage with additional services to promote positive outcomes.

## Children who may need Early Help - (this list is not exhaustive)



We will know if our work in Early Help is successful if it delivers these outcomes:
